The City of Windhoek continues to live by its vision of enhancing the quality of life of all its residents, through rendering efficient and effective municipal services. Testimony to this was the recent celebration of the Rocky Crest 5th anniversary, a state of the art ECD centre located in Rocky Crest which was held on the 13 September 2016 at the centre.

The Rocky Crest Centre started with only 10 learners in 2011 and tremendously expanded to 120 learners in 2016. The centre was constructed to the tune of N\$15 million. Development partners among others such as the Ministry of Education, Ministry of Gender Equality and Child Welfare, City of Vantaa through the North-South Cooperation funded by the Finish Ministry of Foreign Affairs complemented the establishment of the Centre with learning and play equipment including professional and technical support. The centre has been established in an effort to assist the central Government in preparing children for formal schooling. Recognizing importance of Integrated Early Childhood Development (IECD) services, the City of Windhoek established the Early Childhood Development (ECD) Section in 2005 and subsequently ratified the ECD Policy during 2007. The main objective of the aforesaid development is to supplement central government's efforts of providing accessible, affordable and fair ECD services. Two (2) ECD Centres including Rocky Crest and Jonas Haiduwa were established in 2011 and 2012 respectively, and are now fully operational.

Ten years down the line since the inception of the ECD programs in the City, the City made significant progress through its ECD Policy and programs. Apart from the two state of the art ECD centres established, the City with its developmental partners such as the City of Vantaa and UNICEF, has invested in the capacity building for the ECD staff from Khomasdal, Katutura and the informal settlements resulting in more 1000 day care staff to be proud recipients of ECD training. Equally more than 400 day care centres within the city receive guidance to ensure hygiene, safety and quality and this is in line with the overall goal of ensuring improve quality and standards within ECD Centres, coupled with City's developmental agenda of ensuring prosperity for all.

The event was attended by development partners, children, parents, management, councillors including Windhoek Constituency, Cllr George Trepper. In his keynote address during the event, Cllr. Muesee Kazapua, Mayor for the City of Windhoek emphasized Council's primary focus to make bold decisions in shaping the future, as well as working with everyone to forge consensus around some of our greatest challenges of bringing services closer to the people, including the provision of quality ECD services. He appealed to the business communities and other developmental partners to complement the efforts of the City; which are aimed at improving the holistic development of our children as enshrined in the country's development plans. our communities in general to support ECD centres in the City so that they remain institutions that provide hope and foundations for the guided upbringing of our children. "Let us make Windhoek a place of hope and opportunities for all, especially our future gem: our children, by doubling our efforts in investing in them", concluded the Mayor.

Mr. Marcus Betts, UNICEF Country Deputy Representative spoke on the importance of integrated early childhood development (IECD) and the benefits to countries in terms of economic and social benefits. In 2015, UNICEF entered into a partnership with the City of Windhoek to provide technical and financial support to demonstrate the practicalities of providing integrated services at ECD centres. Integrated services include health care, nutrition, infant and young child feeding, child protection and welfare, early stimulation, positive parenting, and pre-school education, which combine all the ingredients for a good start in life.

The pilot project has demonstrated positive

results. The ECD caregivers have received further training to be able to identify, provide support and refer children with special needs. Changes in some parents and auardians have been observed and are supporting activities at the Centre.

While the Ministry of Gender Equality and Child Welfare represented by Mr Develias Naatiiisiue, National Early Childhood Coordinator highlighted on the status of the Early Childhood in Namibia and the way forward, which is that the Ministry of Gender Equality and Child Welfare together with Ministry of Education, Arts and Culture are working on the Integrated Early Childhood Development Framework that provide guidance and recommended actions to the Ministries and all other partners involved in the provision of integrated early childhood development services. Also present during the event was Director of Education in Khomas Region Gerard Vries who urged other stakeholders to create opportunities for the young ones and endorsing policies that are child friendly.

COW SUCCESSFULLY CONDUCTS THE 2016 DISASTER RISK MANAGEMENT SCHOOL INITIATIVE QUIZ

City of Windhoek continues to promote Disaster Risk Management preparedness through its schools initiative since it was introduced by the City in 2004 and scaled up in 2012. The initiative is aimed at ensuring that schools are better prepared for emergencies or disaster that may affect them at any given time. The exercise is part of the Disaster Risk Management Division which is responsible for preparing the residents of the City of Windhoek for any emergency or disaster situation by implementing disaster risk reduction activities aimed at building the resilience of communities within the jurisdiction of the City.

The initiative is focusing on assisting schools to set up Emergency Preparedness Plans and raise awareness on Disaster Risk Management discipline, provision of basic training on the use fire extinguishers, demarcation of assembly

sites, designing of floor plans, carrying out emergency drills and conducting a quiz for participating schools. The Initiative will continue until all schools within the jurisdiction of Windhoek Municipality have participated. To date, 72 schools have participated in the initiative.

Speaking on behalf of the Mayor at the award ceremony, Cllr Ignatius Semba emphasised on the importance of creating Disaster Risk Management awareness to the city inhabitants, explaining that the decision to have EmergencyPreparednessPlansatschool level is an indication of commitment to disaster resilient community and safe City. While congratulating the winners for the 2016 Disaster Risk Management, he applauded the Khomas Regional Director for Education, and the schools for diligently embracing the initiative.

He encouraged all participants to consider themselves as winners, not with prizes, but with the knowledge and skills acquired through participation in the initiatives.

CITY OF WINDHOEK MAYORAL BUSINESS FORUM REVIVED

On 14 September 2016, the City of Windhoek in partnership with the Namibia Chamber of Commerce and Industry revived the Mayoral Business Forum by hosting the second consultation with the business community since its inception in 2013. The Mayoral Business Forum is a platform created at which the Mayor and City leadership interact with the business community on matters related to the economic and developmental agenda of the City.

The long overdue engagement was welcomed with open arms by the business community. Speaking at the forum, Mr. Parastus, Chairman of NCCI Windhoek Branch applauded the City of Windhoek Mayor, Cllr Muesee Kazapua for availing the platform to the business community. Nepolo emphasised that the forum should embark on actively developing economic cooperation that would foster closer cooperation between the City and the Namibia Chamber of Commerce and Industry, in order to address challenges currently being experience.

Some of the challenges highlighted by NCCI hindering the environment in which businesses are operating in are such as; the length process involved in issuance of fitness certificates; compliance certificates land availability for SME'S; Water security; business and building plan approvals and lack of parking around the City especially in the central business district. He further proposed that a technical team be established between CoW and NCCI Windhoek Branch to meet on a regular basis with the aim to tackle challenges together and bring forth solutions.

During his key note address, the Mayor assured the business community of the Council continuous commitment to engage with its residents, and particularly with the business community through the forum; in order to share ideas on how to fast track the economic development of the City. While highlighting some of the major visible developments in the City such as the extension of Wernhill Park, new First National Bank head office and Hilton hotel that face-lifted the central business district area as well as establishment of new malls such Grove mall and B1 City; he called on the business community to consider taking up development opportunities to the western suburbs of the City. "I would therefore like to appeal to you to seriously consider investing into major projects in Katutura. Council stands ready to avail land, for developments that it deems will make positive impacts in the livelihoods of our people, particularly in the western suburbs of our city", said the Mayor.

Although sustainable water availability remains a critical challenge with severe impact on the businesses, Cllr. Kazapua assured the business community that Council is working with central government on how to best mitigate the water shortage in the central area of the country. Mr Pierre van Rensburg, Strategic Executive of Infrastructure, Water and Technical Service presented to the forum on water security. He informed the forum of the mitigation measures that are being employed to ensure security of supply amid challenges. And further urged residents and businesses to lower their demand, by thriving to reach the required target of 40% water saving.

The Mayor also used the platform to invite the businesses to support the less fortunate members of our society through the Mayoral Relief Fund which was approved by Council in June 2016. The fund once launched will be used to support social welfare cases and vulnerable residents. The fund will largely depend on the contribution by good Samaritans and development partners in the private sector. The fund is expected to be launched soon.

About 130 participants attended the forum.

The City of Windhoek donated 100 Solar Powered Lights to the Namibian National Student Organization (NANSO) for onward distribution to the learners as part of the City of Windhoek's corporate social responsibility and mayoral outreach program.

The Namibia National Students Organisation (NANSO) approached the City of Windhoek to donate solar energy lights to the vulnerable grade 10 and 12 learners residing in the informal settlements of the city, through its "Khomas Region's safe and condusive final exam study campaign", as they sit for their national final examinations.

Helena Uutoni, the NANSO Khomas Regional Secretary for Gender and Social Welfare, underlined the fact that there is a need for improvement in the performance of learners in their National Examination in Khomas Region, to be top on list of the performing schools in the country. Uutoni explain that, although learners in Khomas Region especially in Windhoek are exposed to resources such as libraries compared to other regions; most of these learners are facing some

serious challenges of basic services such as electricity, especially those residing in the informal settlement. Therefore, in order to see changes in the learners' performance, there is a critical need for private and public partnership to be formed in order to gather resources for the uplifment of the learners. She thanked the City of Windhoek for its generous contribution toward the campaign and promised that the donation will be distributed to the intended recipients.

Handing over the donation, the Mayor, Cllr Muesee Kazapua applauded NANSO Regional leadership, for the great initiative aimed at assisting learners who live in areas without electricity, as they prepare for their final examinations. He explained that, half of the solar lighting systems were donated to the City of Windhoek in July 2016 through its international cooperation with its sister city of Nanjing in China. This is therefore testimony that international cooperation is not confined to the City Hall or Council Chambers, but it brings about tangible benefits to the people. The City of Windhoek is aware that alone, it cannot adequately deliver on

service delivery commitment; hence it values contributions and support from its development partners in the corporate, public and civil society sectors.

therefore called He upon beneficiaries, to take maximum care of the items, and use them for intended purposes, as there remain so many other leaners and vulnerable people in need; who could not benefit from this donation. "I know a lot of you have challenges in your lives that can make it hard to focus on your schoolwork. I for one also had a difficult time during my school years. But at the end of the day, the circumstances of your life is no excuse for neglecting your studies", said the Mayor. He further assured all residents in the informal settlements that Council is working very hard to find solutions to the general provision of basic services, which include electricity.

The identification for the potential beneficiaries was carried out by the NANSO Regional Leadership themselves upon submission of their request. The lighting equipment donated is valued at N\$45 000-00.

Heading to the Mayor's call, to provide support to 8 year old Riraranda Murangi, NAMSOV Community Trust donated monthly support of food from Pick and Pay to the value of N\$ 1,000 as well as gas refuelling at Afrox Namibia to the value of N\$ 500; monthly medical support at Victoria Pharmacy and monthly GP visit check-up care. to go a long way in continuing support to several vulnerable community cases and upon the launch of the Mayoral Relief Fund. His Worship Mayor Kazapua, also highlighted that the Fund will be annually audited, and funding will be sourced from local business and that its operations will be transparent, with clear criteria to be set that will determine fund recipients.
