
the efficient track record of leadership and excellent expertise of Kahimise.

INCIDENCES OF DISCOLOURED TAP WATER IN CERTAIN SUBURBS

The City of Windhoek would like to inform the public that it is aware of the reports of discoloured tap water being experience in certain instances.

It should be noted that with the ongoing water supply crisis the City of Windhoek (CoW) has been forced to make significant changes to the supply in terms of the origin of potable water.

Currently, the CoW is pumping previously unprecedented volumes of groundwater from the Windhoek Aquifer.

The character of the water from a number of the new boreholes is yet to be established as pumping intensifies.

In addition the reconfiguration of the distribution system can lead to long established residue finding its way into reservoirs and eventually consumer supply.

Despite these challenges the City of Windhoek is continuing its stringent water quality monitoring programme and we wish to reassure all consumers that all water distributed is of an excellent quality and perfectly safe for human consumption.

Notwithstanding these assurances and in order to properly address any underlying issues in terms of water quality, the public is encouraged to continue the reporting of any persistent changes in the colour of their tap water or otherwise to our Scientific Service at 290 3462 / 3469 / 3470.

We count on your usual support while assuring you that we will continue to deliver services of an excellent standard.

The City Council at its first ordinary meeting held on 26 January 2017 approved the additional tariffs adjustment for the 2016/2017 financial year.

The approved tariffs will be gazetted and implemented effective 15 February 2017.

Council reviews its tariffs structure on a yearly basis in order to recover direct cost as well as indirect cost related to the products and services it delivers to its customers.

During the year production costs increased on goods and services. This directly affects the costs of products and services delivered by the City of Windhoek.

ROADWORKS ALONG NELSON MANDELA AVENUE

Description of the Project:

City of Windhoek Borehole Pipeline. A large diameter pipeline is to be constructed from Avis to Central Reservoirs.

This pipeline will anable the City of Windhoek to transport borehole water from the Eastern Wellfield to the Central Reservoirs from where it can be distributed into the water network. This project is part of the Emergency Water Supply Plan.

Description of the Affected Streets:

The pipeline route follows Sam Nujoma Drive from Avis into Hebenstreit Street, then into John Ludwig Street and then north in Nelson Mandele Avenue to Metje Street, up Metje across Dr. Kenneth David Kaunda Street and then up the mountain to Central Reservoirs.

The pipeline will be on the northern sidewalk of Sam Nujoma Drive and on the eastern sidewalk of Nelson Mandele Ave.

Duration:

The construction portion of the project commenced in November 2016 and will be completed in September 2017. Work started from Central Reservoirs and will proceed towards Avis.

As from August 2015, the City of Windhoek embarked upon a General Revaluation of all Rateable Properties within its jurisdictions in accordance with section 66 (1) of the Local Authority Act, Act 23, of 1992, Council Resolution no. 07/02/2015 and Government Gazette no. 5795 of 31st July 2015.

The next phase of the General Valuation of all rateable properties is moving to the inspection and valuing of properties beyond the peripheries of Windhoek suburbs.

These are Brakwater, Nubuamis,

Emmarentia, and all the farms and portions found in the extended boundaries of the City of Windhoek.

Therefore, the City of Windhoek would like to humbly request property owners in the above mentioned areas to let in properly identifiable Valuers and Data collectors (identifiable with work cards and supporting letter from the City of Windhoek) from SEEDS PROPERTY SOLUTION CC to enter their properties for the above said valuation purposes.

This exercise is scheduled to start as from

Monday, 30 January 2017 until Friday, 28th April 2017 and it will be carried out during working hours.

CITY DRILLING FURTHER BOREHOLES IN ORDER TO UP

WATER SUPPLY

The City of Windhoek is in process of drilling further boreholes in order to increase water supply for domestic consumption from the underground aquifer. So far about eight boreholes have been completed, with the ninth one in process of being drilled. The process of drilling a borehole can take about three months, with total cost amounting to about N\$ 8 million per borehole.

Borehole drilling is an expensive meticulous process that requires extensive planning and heavy equipment. Machinery required in water drilling are expensive and a substantial borehole drilling plant require total invest cost of about N\$ 60 million. It is becoming ever expensive to supply water to the City, and it is

important that the resident appreciate the water resource available in their water network. Due to the ongoing limited water supply, it is important for the resident to adopt a habit of utilising water sustainably.

Water from the boreholes is normally naturally clean and get pump straight to the City's reservoir where it is further redistributed into the domestic water supply network. During the drilling stages, a borehole has to be drilled up to the depth of between 350 to 400 meter, and Windhoek being a mountainous rocky area drilling operation can be halted due to drill bit replacement and or sharpening, identifying a specific spot to drill requires technical expertise with appropriate equipment. The life span of a borehole depend on the level of extraction,

available amount of water in the aquifer, as well as the rate of replenishment, currently the eight boreholes drilled so far each provide about 120 cubic metre of water per hour.

Windhoek consume about 27 million cubic metre of water per annum. Boreholes are however are not a permanent solution to Windhoek's water predicament, and it is important that a permanent water source is found soon. The three dams namely; Omatako, Swakop Poort and Von Bach Dam have for years been the main source of water supply to the city, which have dependent on natural replenishment during rainy seasons, but this is unfortunately no longer the statuesque due to limited rainfall.

VEHICLE WASH FACILITIES REQUIREMENTS

The vehicle wash registration process requires the following:

- 1. Any carwash may only be operated on a business zoned property. To rezone to a business property, if possible. (This process takes eight months and longer) Business consent is not acceptable.
- 2. Sufficient space has to be available on a property to operate a carwash. For each wash bay, a number of parking bays are required on the property. If so, a building plan, in line with the building regulations for carwash operations has to be submitted for approval. (The approval can be obtained within three months)
- 3. Upon the approval of the building plan, the infrastructure has to be upgraded to the approved building plan.
- 4. Only after the implementation of the above 3 steps, the client can apply at Business Registration for a Fitness Certificate. (The consent to operate or the fitness certificate can be obtained within one month).

All Laws and municipal bylaws related to car wash operations will be enforced and with the following basic requirements:

- Compliance to building regulations
- Valid fitness certificate
- Water efficiency standard to be endorsed.

It is in the City of Windhoek's interest to provide a safe and prosperous environment for all citizens. Water efficient carwash operations will be enforced by the CoW. The onus remains on the operator to manage such carwash operations in a water efficient manner.

Waterless carwash operations would be the only alternative for residential erven, if so approved on own merit. All mobile and waterless carwash operators have to obtain a fitness certificate.
