Let us continue to work together to maintain a safe and clean environment. A healthy environment is one that is free of pollution.



# Official statement by Mayor Sade Gawanas during the monthly council meeting of 16 May 2022

It is my honour and privilege to welcome you all to our 4th monthly Council meeting of the year 2022. I am happy to note that our residents, the media, and indeed those who are interested in our efforts around the world, continue to show an interest in our deliberations, through the virtual platforms that have been provided. I would further like to extend my sincere apologies, as this meeting was set to take place on April 28th, but due to unforeseen circumstances, it could not take place on the said date.

Hon Councillors, as we gather in this Chamber, it is of utmost importance to state that we constitute a City Council, assigned to serve the interests of all the residents of this beautiful city. irrespective of their political orientations. In a nutshell, Honourable Councillors, I humbly implore us all to create a need in a moment; as such, to set aside our political differences, so that we may work in one accord, together as a team with a mission and a goal: to liberate our residents from the lack of adequate basic necessities. It is therefore important to note that the tone, language and posture we set in this house will serve as the vardstick as we strive to deliver service excellently to our people. In the same vein, I would like to stress that cooperation, understanding, and support from the officials are equally of the utmost importance, as I firmly believe that the cooperation centred on Councillors alone will not be sufficient in our efforts. The aim is to bring forth the aood deliverance that the residents are expectant of from this August Council House. So, let us, therefore, work towards delivering on their needs and addressing the challenges facing them with meekness.

Valued Residents, Please be informed that Council is working at its best to take deliberate, but cautious actions, with the main objective of tackling your needs with goodwill, especially for those living in the underprivileged informal settlements. During the past few weeks, the Council has been busy budgeting sessions, consulting relevant stakeholders and prioritizing our estimates for the Financial Year 2022-2023. We also spent time crafting our organizational strategic plan for the years 2022-2027. These sessions are ongoing, and we hope to finalize the budget soon before submission to the line the Ministry for final approval. The annual budgets and strategic plan will continue to serve as our guide, as we take on projects that we believe will have a positive impact on the lives of our people within the constraint of financial sustainability.

In addition, Council fully understands the pressing needs of our residents when it comes to housing, which, indeed, up to this point, remains a national challenge. In this regard, the Council will continue in their efforts to accelerate the provision of housing to those in need. The projects of pre-allocation of plots to our residents and provision of water and sanitation to informal areas will remain a top priority to Council. We should, however, agree to the fact that the accumulation of housing shortage and settlement needs of the Windhoek Residents is a huge task, which cannot be alleviated within one financial year. However, our pledge to the improvement of the quality of life of our people remains our fundamental supervisory

custom. Honourable Councillors, Esteemed Residents,

On the current affairs, I am pleased to inform you that during the course of April month I led a delegation that included the Deputy Mayor, Cllr Joseph Uapingene and Chairperson of Management Committee, Cllr Ndeshihafela Larandja together with the Acting Chief Executive Officer on a courtesv call to the line Minister of Urban and Rural Development, Hon. Erastus Uutoni. The purpose of the courtesy meeting was mainly to brief the Minister on developmental issues facing the Municipality of Windhoek, in order to find common ground and measures at which the Ministry could assist, with regard to the challenges. Amongst the issues discussed is the Affordable Housing Project that has been jointly being implemented by the line Ministry, KRC, City of Windhoek and NHE. The City of Windhoek alone has thus far completed more than 300 houses. As a result, I am very pleased to inform you that, in consultation with the line ministry and other stakeholders, the City of Windhoek is in preparation for an official handover event of the completed houses planned to take place before the end of May 2022. Our appeal is, therefore, that the ongoing Council effort through the provision of affordable housing and other programmes should be embraced.

## Highlights from the Municipal Council of Windhoek ORDINARY COUNCIL MEETING HELD ON 16 MAY 2022

## The Municipal Council of Windhoek has approved the following items amongst others:

Approval of the revised Disaster Risk Management Plan



The City of Windhoek's current Disaster and Risk Management Plan (DRMP) was developed from the Civil Defence Ordinance (Ordinance No.3 of 1979) in 2002. This ordinance was since replaced with the Disaster Risk Management Act (Act 10 of 2012). In order to align the City's DRMP to the current national and international frameworks a revised plan was compiled, after wide consultations, in 2018. This revised DRMP serves to guide the organisation's preparedness and response approach to risks such as fire, flash floods, epidemics, and transport accidents to mention but a few. The Municipal Council of Windhoek was designated a disaster management institution by the Namibian Disaster Risk Management Act (Act 10 of 2012) and must therefore establish a Local Authority Disaster Risk Management Committee, with the mayor as chairperson and the deputy mayor as vice chairperson. The chairperson of the COuncillors Advisory Committee on Economic Development, Public Safety and Citizen Welfare will form part of the Local Authority Disaster Risk Management Committee.



Special project: Application for the waiver of restrictive resale over portion 320, a portion of portion B of Windhoek Town and Townlands No.31 and Submission of an amended development proposal Streethouse Entertainment (PTY) LTD



Council resolved not to support a request by Streethouse Entertainment (PTY) LTD to waive the restrictive resale conditions of 10 hectares of land allocated to it for a project under the City of Windhoek (CoW) Special Projects Policy. The policy forms part of the CoW local economic development strategy which provides private developers the opportunity to acquire municipal land for unique development purposes without going through the tender process, if their business proposal meets the set requirements. In 2008 Streethouse Entertainment (PTY) LTD applied to purchase land, southeast of the proposed Rocky Crest Extension 8 for an amusement and recreational park of 20 hectares. The final approval was given in 2013 and the Deed of Sale was signed in 2015. The applicant failed to construct the bulk services or effect any development whilst also encumbering the property with bonds to the value of N\$24 million. A number of conditions are imposed on special projects to prevent speculation and ensure that the land is developed for its intended purpose as a special project.

The learners will serve in the position for two years. They will be equipped with knowledge of the operations of local governments and empowered to participate in civic projects that benefit their communities. The junior councilors' core project this year will focus on mental health issues. With this new role, Moses wants to inspire everyone, especially the next generation, to instill change in their lives and the communities. Fenn Paulus, the deputy mayor, equally shares the same sentiments. In her message after winning, she expressed excitement saying she is looking forward to developing herself and working together with

her fellow councilors to achieve great things in the community.

The City of Windhoek Junior Council was established in 1999 to, amongst others, be a vehicle by which learners can be involved in their communities and create change through the young initiative programme.

# Used cooking oil initiative

## 1. Background



Cooking oil derived from plants, animal, or synthetic liquid fat is used in frying, baking, and other types of cooking. Various types of oils are also used widely as condiments to enhance food taste. Used Cooking Oils, or UCOs, are oils and fats that have been used for cooking or frying. UCOs are commonly found in the food processing business, such as restaurants and fast food establishments, as well as in homes. Reusing cooking oil have been found to be a common practice, but it can pose some serious health hazards. Oil that has been reheated and reused repeatedly has been determined to be unsafe for human and animal consumption.

Apart from the serious health effects that result from the use of UCO, the City of Windhoek has encountered problems with the disposal of UCO. UCO is illegally disposed into the stormwater drains resulting in the pollution of the rivers and disposed in the sewer system causing blockages of the sewer.

In light of this, the City of Windhoek Health and Environmental Service (HES) Division together with Biofuel Namibia has developed the Used Cooking Oil Initiative aimed at collecting the used cooking oil for recycling it into Biofuel.

## 2. Objectives

The objectives of the initiative are;

- Develop UCOs Collection program for Municipal Council of Windhoek
- Educate and guide the commercial and public community with regard to the dangers of reusing cooking oil, and the proper disposal methods available.
- Introduce the UCO's waste manifesto, to ensure that UCO from various establishment is monitored, handled and disposed of correctly in the Windhoek jurisdiction.

## 3. Campaign Information

## Why is Re-using Cooking Oil bad?

If your restaurant or takeaway uses cooking oils to bake, fry or cook, then you probably sell or re-use your oil. What you don't know is that each time oil is heated, dangerous substances are released both into the air and into the food being cooked. This causes a health hazard to your workers and customers!

- 1. It can cause Cancer. Research shows that re-heated oil contains toxic elements which can cause cancer. It also causes other deadly diseases such as obesity, heart disease and diabetes.
- 2. It increases the risk of heart disease. Food cooked in black and smoky oil which is being used and re-heated throughout the day can increase levels of cholesterol and heart attacks.

## **Registered Used Oil Collectors**

At the moment, the Council only has one registered Used Oil Collector named BEE Biofuel Namibia. You can call Biofuel Namibia at +264 81 289 4284 to arrange the safe disposal of your Used Cooking Oil.










Cooking oil may not be re-heated until is no longer fit for reuse. Once your cooking oil turns a shade depicted in 3 below, you need to **STOP** using it immediately.



## Correct disposal method

Steps to follow;





**THREE:** Put bottle with lid into your food waste bin

## DON'TS

 Don't - Pour cooking oil down the sink! It will cool down in your water pipes and harden, causing blockages.



- 2. Don't- Re-use cooking oil until is no longer fit for human or animal consumption!
- Don't Sell used cooking oil or give it away to your employees as it is a health hazard! Food Outlets found doing this are committing an offence and will be fined.
- 4. Don't Mix used cooking oil with animal feed as it will make the animals sick!

## Pouring in the sink associated effects

1. Pipe blockage resulting in back flows.



## DO'S

 Do – Pour used cooking oil into a container. Seal the container with its lid, then store it in a wellventilated room until collection.



 Do – contact the registered cooking oil collector to collect your used oil.



- Do Ensure that you receive a disposal certificate from the used cooking oil collector
- 4. Do Replace your cooking oil after it is no longer fit for use.

# Motions submitted at council meeting of 16 May 2022

Bestowing and conferment of the title of Alderwoman to Councillor Fransina Kahungu in line with Council Resolution 393/11/2010

## Background

Council, in resolution 393/11/2010, read with section 30 (1) (q) of the Local Authority Act, resolved to honour Councillors for long and meritorious service either by bestowing of an honorary title or award. Council, in the above captioned resolution, specifically resolved that "for ten full years of service and more, the honorary title of Alderman/Alderwoman plus a bronze medal and certificate" be given to the Councillor fulfilling these requirements.

#### **Motivation**

Having being elected as a member of the Municipal Council of Windhoek during the 2010 Regional and Local Authority Elections, and subsequently being re-elected during both the 2015 and 2020 elections, it is common cause that Councillor Francina Ndateelela Kahungu has served on the Municipal Council of Windhoek for more than ten years. She also served as a Member of Management Committee, Deputy Mayor and subsequently Mayor of Windhoek. It thus follows that Councillor Francina Ndateelela Kahungu has indeed fulfilled the requirements set in Council Resolution 393/11/2010.

#### Way forward

This Motion thus calls for the following;

- 1. Conferment of the title of Alderwoman to Councilor Francina Ndateelela Kahungu.

Changing of the legal name from Municipal Council of Windhoek to the City of Windhoek in line with Section 4 (1) (F) of the Local Authority Act.

#### Background

Section 3 and 4 of the Local Authority Act makes provisions for the declarations of areas of local authorities as municipalities as well as the alterations of declaration of local authorities. For the case of Windhoek, there appears to be common understanding that the legal name is the Municipal Council of Windhoek. Be that as it may, the name City of Windhoek is also used inside and outside Council. This name, City of Windhoek, which appears on the official documents and identity of Council, has also entered/appeared in the official national records. I attach the official government gazette No 7418 of 15 December 2020 with the name City of Windhoek. This creates confusion as to whether it is Municipal Council of Windhoek or City of Windhoek.

#### Motivation

This confusion needs to be cleared and a common name be adopted in line with the relevant laws of our country. Any analysis of the utilization of the two names will lead to the conclusion that the name City of Windhoek, is the preferred as it is widely used compared to Municipal Council of Windhoek. This can be done through section 4 (1) (0 of the Local Authority Act that authorizes the Minister to alter the name of a local authority.

#### Way forward

- This Motion thus proposes as follows;
- 1. That Council formally adopts the name City of Windhoek.
- 2. That Council requests the line minister to effect this change in government gazette.

## Background

Colonialism has negatively impacted the Namibian nation at large and its repercussions haunt us till date. There is a need to bring the conversation on the respective implications of colonialism to this chamber today because the city stands on the ancestral lands of three ethnic groups that historically inhabited historical Otjomuise / /Ae //Gams currently known as Windhoek. The Ovaherero, /Khomanin Damara and the Afrikaner Nama coexisted amongst each other despite the skirmishes amongst Herero and the Nama. The hot springs and the water fountains were the main source of water and the main lifeline for both humans and animals and these tribes they nomaded around this location.

I am cognizant of the fact that the traditional demarcations of Otjomuise / /Ae //Gams of yesteryear are different from the modern geopolitical demarcations as the traditional demarcations stretched beyond the current borders. The pastoral Herero tribe kept large herds of cattle on large parcels of land, whereas the Nama and Damara were small stock farmers. The Ovaherero clans owned large tracks of land per clan as necessitated by the number of herds of cattle that they owned. Kaitjene wa Muhoko and his family and part of the Afrikaner Namas, for instance, lived were the current Eros Airport is located in Pioneers Park. Their land stretched as far as Gamsberg Pass Mountain including the land where the main campus of the University of Namibia is located. His eastern boundary bordered with ehi raNguheva currently known as Groot Aub Nguheva coinhabited with part of the / Khomanin Damara in that area. Part of the Muundjua clan lived behind the current Koreangab Dam and their land stretched to Olcuryongava and beyond.

These ethnic groups were forcefully dislocated by German regime from the city and the Ovaherero and Nama subsequently waged war which resulted in the horrendous genocide. Despite the Damara not being targeted by the German extermination, the /Khomanin Damara amongst others lives the repercussions of the dislocation in contemporary Namibia. From the concentration camps, the Nama and the Herero groups were located into Bantu Stands that served as holding camps for the Germans when they needed slaves

after the closure of the concentration camps. This holding camps were turned into Ondedaal reserves by the Apartheid regime and were tribally demarcated and allocated. The Ondedaal reserve commission was also applied to the / Khomanin Damara. During the colonial period in the 1960s the Odendaal Plan moved the /Khomanin people to Sorisoris from /Khomas, to Erongo region under jurisdiction of Daure — Daman and to Okombahe under the jurisdiction of the !Oe - #gan Traditional Authority.

In 2012, the City of Windhoek expanded its boundaries, thereby further annexing ancestral lands without the express consent of the traditional communities. An example of this is Augeigas (correctly spelled as !Aollaexas) to the west of Otjomuise / /Ae //Gams. This expansion also includes #Arovlei.

This brief historical context serves to remind those aware and to conscientize the members of this council as aforementioned that the city today lies on the ancestral of the Ovaherero, /Khomanin Damara and Afrikaner Nama communities.

For indigenous peoples, land is more than an economic commodity. It has guided their way of life for generations. This notion is particularly prevalent in Africa, where many diverse indigenous communities exist, from desert regions to vast forests and it applies to these three ethnic groups today. Accessing, utilizing, and claiming land and its resources was the original source of material wealth and the basis of a civilization's prosperity. However, for indigenous peoples, land is much more than solely a source of income. As Barume (2010) states, "ancestral territories are the basis for their livelihood, way of life, culture, and existence as communities" (p.10). This paradigm is particularly relevant to the African continent, where the numerous and diverse self - identified indigenous groups retain a sacred, spiritual, and cultural connection to their land. The prominent late Ouma /Hones of the /Khomanin was laid to rest in that is currently known as Havannah on the outskirts of Windhoek thus connecting, this community to this specific location.

The United Nations Expert Group (2018) states that "lands and territories are crucial not only to the well-being of indigenous peoples but to their very existence as distinct peoples". It is said today that these communities need to drive from as far as Eiseb Block for burials in Windhoek because this is where their ancestors are laid to rest. The 1 Khomanin Damara in independent Namibia are faced with a

land apocalypse as a consequence of displacement and relocation. Introduction to urbanization, albeit a global pattern and not necessarily unhealthy, would appear to diminish a group's identity and rights as indigenous peoples and traditional community, whose traditional norms, culture and rituals are more rural landbased. Development interventions often erode communal land management, affecting indigenous economy, society, and culture and thereby triggering impoverishment, social isolation, and marginalization among these communities just as to the /Khomanin peoples today.

#### **Motivation**

This confusion needs to be cleared and a common name be adopted in line with the relevant laws of our country. Any analysis of the utilization of the two names will lead to the conclusion that the name City of Windhoek, is the preferred as it is widely used compared to Municipal Council of Windhoek. This can be done through section 4 (1) (0 of the Local Authority Act that authorizes the Minister to alter the name of a local authority.

#### Way forward

## Establishment of Windhoek education fund to assist needy students in Windhoek in line with Section 30 (1) (p) of the Local Authority Act

## Background

On the 20th September 2021, in my capacity then as Mayor of Windhoek, I addressed the attached memorandum to Councillors and employees of the Municipal Council of Windhoek asking them to make a contribution to the seed capital that will establish the Windhoek Education Fund.

There was a positive response particularly from the employees. More encouraging, lower ranked employees signed up for monthly deductions for they understood the importance of planting trees for future generations to have shade although one may not be able to experience the same during their lifetime.

Employees signed a voluntary contribution form, also contained in the attached memo, to enable direct deductions from their salaries. The finance department was generous enough to create a budget vote to which all monthly contribution were channeled. Human resources and finance departments are working together on this matter.

At the last update I received, close to 200 employees had signed these forms and it is estimated that close to N\$ 100 000.00 has been collected thus far.

## Motivation

Section 30 (1) (p) of the Local Authority Act allows Council to "allocate bursaries, and grant loans, for educational purposes'. As such, the establishment of the Windhoek Education Fund fulfils this statutory provision. The approach taken was first to test commitment and willingness before the formal establishment. At this stage, the evidence shows that there is an interest and much of the groundwork has already been done. The seed capital is now established and in position of Council. Be that as it may, Council, as a highest decision-making body still need to formally approve the fund.

## Way forward

This Motion thus proposes as follows;

- That Council herewith establishes the Windhoek Education Fund in line with Section 30 (1) (p) of the Local Authority Act.
- 2. That the collected amounts collected from employees be channelled to the fund.

3. The Chief Executive Officer develops further mechanisms for the operationalization of the fund inclusive of the terms of reference for approval by Council



#### Establishment of Windhoek football club (Windhoek FC) to participate in the national football league

## Background

The importance of sport to a modern society cannot be overemphasized. Sport in general, and football in particular, has a multitude of benefits such as social harmony and cohesion, social stability, socioeconomic benefits and contribution towards nationhood and patriotism. Football is one of the famous, if not the famous, sporting codes in Namibia and the world. The presence of City-owned team, Windhoek FC, in the national football league would by implication mean a City's presence at both national and international level. It will also assist the efficient and effective operations of Sam Nujoma Stadium which currently is not run efficient and effectively. Windhoek FC will take over the stadium and run it effectively as is the case with most football clubs internationally. Having a city-owned team will assist the City in successfully leveraging the exploits of the football economy from which the City presently benefits minimally.

The ownership of football clubs by public bodies is not a new phenomenon. There have been several successful football clubs owned by the public. Successful football clubs such as Paris Saint-Germain FC that recently signed international football star Lionel Messi was previously publicly owned before it was sold in 2011. Persepolis in Iran, CSKA Moscow in Russia, Beijing Guoan in China are all owned directly and indirectly by the public. Spanish football giants Real Madrid FC and Barcelona FC are owned by the public through what is called SOCIOS or sods whereby fans registered fans, who pay annual membership fees get the right to vote at assemblies of delegates or get represented by their elected representatives who run the club. There are several models that the Council can consider in the establishment of the Windhoek FC.

## Motivation

The purpose of this motion is to assert the Municipal Council of Windhoek leadership in sport. Council, for a considerable lengthy period, has seen its role as limited to facilitating sport and not in the provision of the necessary leadership in the nation's capital. The establishment of Windhoek FC will signal such decisive approach and providing direction to sport.

## Way forward

This motion thus proposes as follows;

- That Council herewith establishes a Football team to be known as Windhoek Football Club (short Windhoek FC) that is fully owned by Council through Nova Actus Holdings (Pty) Ltd to participate in the national football league.
- 2. The Chief Executive Officer (Strategic Executive Economic Development and Community Services and Chief Corporate Legal Advisor) ensures the practical establishment and registration of the team by engaging with the relevant national football bodies in the country.
- 3. That upon the practical establishment and registration of Windhoek FC, a Steering Committee, consisting of football legends and experts in Windhoek, be appointed to map out the manifestation of Windhoek FC.
- 4. That once Windhoek FC is operational, the Sam Nujoma Stadium be given into the custodian of Windhoek FC.
- 5. That the Chief Executive Officer provide monthly report to Council on a monthly basis until Windhoek FC is fully registered and operational.

By establishing Windhoek FC, Council will provide the necessary leadership that will contribute to social harmony and further the City's identity. Council is also positioning itself towards an efficient and effective management and utilization of Sam Nujoma Stadium that is present administered by the City bureaucracy while football stadiums are internationally run by football clubs. Council also stands to benefit from the football economy from which it doesn't benefit presently.



## APPOINTMENT OF O'BRIEN HEKANDJO AS ACTING CHIEF EXECUTIVE OFFICER



The prepaid water meters are installed for individual household connections in Mariental Street in Havana and various points in other informal areas. This will enable residents to have control over water consumption and cost. Speaking at the occasion, the Mayor said that the introduction of the prepaid meters will increase the City's business efficiency to deliver the most value at the least possible cost. In order to ensure the sustainable delivery of high-quality municipal services, the Council endeavors to implement quality control measures that will not only ensure cost control on the side of the residents but also convenience. Therefore, Council will allow residents to choose between the Monthly Prepaid Water Repayment, as an option that applies to customers who cannot afford to pay upfront for the Prepaid Water Meter Service Connection Fee over a repayment period of 5 years. The prepaid water meter product is available for every resident. However, priority will be given to pensioners, vulnerable and default customers. To apply for a replacement or new connection, please visit the nearest municipal office.
